#### A. READING THIS AGREEMENT:

In this Subscription Agreement, the words "I", "me" and "my" refer to the undersigned subscriber for the Bond, and the undersigned subscriber can be an individual, a corporation, a trust or an unincorporated association. If there are two subscribers jointly subscribing for the Bond, then "I", "me" and "my" should be read as "we", "us" and "our".

## D. MY STATEMENTS:

By signing this Agreement, I am telling Stewards Canada that the following statements are true:

- a) I have read and I understand the **Information Memorandum** accompanying this Subscription Agreement, including all of its Schedules, and I acknowledge that the terms and conditions that apply to the Bond, as described in the Information Memorandum, are binding on me;
- b) I understand that I will be sent a Bond Certificate, on receipt by Stewards Canada of one executed copy of this Subscription Agreement, a copy of one piece of picture identification for each person named on this Subscription Agreement, and a cheque for the Total Price of the Bond made out to Stewards Canada, unless this subscription is rejected, in which case the Subscription Agreement, identification and the cheque will be promptly returned to me;
- c) I understand that I could lose some or even all of the Total Price of the Bond. I acknowledge that the Bond is an unsecured obligation of Stewards Canada, a non-profit corporation incorporated under the laws of the Province of Ontario, and that the Bond is not guaranteed by the Canada Deposit Insurance Corporation ("CDIC") nor by any other government agency or body;
- d) If I am an individual (as distinct from a corporation or other entity) then I confirm that the aggregate amount I am purchasing, represented by the Total Price of the Bond, is prudent and reasonable, in view of my total net worth, excluding the value of my equity in my primary residence, my income and my personal financial circumstances;

3. If interest payments are to be deposited to the subscriber's bank account, please attach a voided cheque showing the bank account number of the subscriber's bank account.
4. For a bond registered in an Assembly/Church name, please provide the organization charitable registration number on the "SIN #" line.
